As of January, our back parking area is being enhanced, with lots of additional spaces, walkways and lighting that will greatly improve access to our building. For this reason, we have temporarily moved our PPT Show to Westside Market, Roswell, where there is ample parking, visitors and plenty of space to hang our show. In addition, WSM is open seven days a week. We would again like to invite you to participate.

Our format will be the same as last year, you will enter your artwork images virtually for selection by our judge, nationally known local artist, Elizabeth Carr. Selected works will be brought to Westside Market and prizes will be judged in person.

The space at Westside Market allows us to hang larger works and we have room for a substantial number of pieces so we are offering you the opportunity to enter larger works and up to five pieces. **Please carefully read all of the details in the attached Prospectus.**

The deadline to enter your images will be January 13 by midnight. Your entry fee must be paid by January 11.

Eligibility, Rules and Information

Include Artist's first initial, last name, title, size on each jpeg. **In the body of the email Include:** Artist's name, titles, sizes, and mediums

- Show is open to (paid) members and non-member invited guest artists.
- ENTRY FEE = \$20 up to 3 works. \$25 = up to 5 works. Please make checks payable to **Roswell Fine Arts Alliance**.

- Only the following **original** fine art will be accepted for this show: paintings, drawings, collage, pastels and mixed media.
- All two dimensional work must be gallery wrapped, (at least 1" stretcher, no staples showing) or framed, with a **wire hanger** on back (no saw tooth hangers or rings will be accepted).

NOTE: Wire hangers should be at least 4 inches below top of frame and secure

SIZE = Up to 168 inch maximum size around perimeter excluding frame. NO HEAVY FRAMES PLEASE. If you enter max. size works – no more than two + up to 3 smaller works (11 x 14" – 16 x 20" or equivalent)

- Securely attached to the back of each piece should be: artist's name, title, medium, dimensions and artists phone number (see attached labels).
- Works submitted should be completed within last 5 years.
- Works shall not have been accepted to a previous PPT Show.
- Only works accepted by our judge may be submitted; no substitutions will be allowed.
- Works accepted in this show must remain in the show until the take down date. A 20% commission will be charged for early removal of a work.
- An RFAA waiver of liability and one for Westside Market must be signed for acceptance.
- All accepted works must be listed on a completely filled out entry form which will include the artist's name, phone number(s), email address, titles of works, mediums used, and prices (see attached).
- RFAA will make cards for the front of each work with artist's name, title of work, medium and price.
- All works submitted must be for sale A 20% commission will be collected for all works sold during the show
- All works entered in shows must be picked up by the artist/artist's representative at Westside Market on the return date or **prior arrangement must be made with the Show Chair.**
- Controversial themes such as political or religious, and frontal nudes will not be accepted.

We will exercise the same care when transporting artwork to and from our venues (during certain shows). **WE (RFAA, ROSWELL RECREATION AND PARKS, AND OUR VENUE OWNERS, MANAGERS AND STAFFS) ASSUME NO FINANCIAL RESPONSIBILITY for loss, theft or damage to artwork should it occur.**

By signing this waiver, I agree that if I enter a show where artwork is transported from one venue to another, **I give my permission to have my art transported. (Members Only)**

I agree that photos of my work and of me in attendance at RFAA receptions and functions may be used for publicity purposes.

I understand and agree that should I remove any of my artwork before the close of the show or venue session, I will pay Roswell Fine Arts Alliance a commission of 20% of the sale price for each piece I remove early.

Further, I understand that the responsibility for care of my artwork ends on the closing date of the show or venue session and that any of my works not picked up on that date become my responsibility. RFAA may store uncollected works in the non-climate controlled Garage of the Gallery on Fouts Road (unless other arrangements have been made between the Show Coordinator/Venue Chair and the artist). Paintings not picked up within 30 days could be donated to charity.
